## **Funding Opportunities:**

**Charles Hollenberg Summer Studentship Program** 

Deadline: 21-Jan-21 Amount: \$5,985

Summer studentships to **undergraduate and medical students** to carry out summer research in diabetes. A stipend of \$5,985 will be offered to successful applicants. Note that the Banting and Best Diabetes Centre will provide \$2,992.50 and a minimum of \$2,992.50 must be provided by the supervisor. Students are required to work full-time for a minimum of 12 weeks between May 1 and August 31.

Canadian Foundation for Infectious Diseases AMMI Canada- CFID Medical Student Research Award

Deadline: 22-Jan-21 Amount: \$5,000

January 15, 2021

Provides support for **medical students** who are interested in research in infectious diseases and microbiology. Successful applicants will receive an award of \$5,000 for an 8-10-week research term that is performed consecutively over the summer, or intermittently over the course of one academic year.

Canadian Foundation for Infectious Diseases CFID Undergraduate Summer Research Grant

Deadline: 22-Jan-21 Amount: \$5,000

Provides support for **undergraduate students in their 2nd year or higher** with a minimum GPA of B+ (3.33 or 76%) conducting research relevant to the diagnosis, treatment, or prevention of infectious diseases. Successful applicants will receive an award of \$5,000 for an 12-13-week research term that is performed either as a summer research project, an elective research term, or a co-op work term.

#### Society of Hospital Medicine: Student Hospitalist Scholar Grant

Deadline: 31-Jan-21

Amount: \$5,000 student stipend and up to \$1,500 travel expenses

This award is for **medical students.** Awardees will receive \$5,000 for an 8- to 10-week summer research project. Additionally, up to \$1,500 will be reimbursed to the student for travel-related expenses to attend the annual SHM Hospital Medicine conference.

### Canadian Association of Gastroenterology Summer Studentship Awards

**Deadline: 31-Jan-21** Amount: \$6,000

This award is open **to first-time undergraduate students.** Successful applicants will be awarded a stipend of \$6,000 for full time work on a research project for 4 months (May to August). An additional \$1,000 will be awarded to the top ranked applicant for the Ivan Beck Memorial Summer Studentship.

### CurePSP Urso Summer Student Fellowships (for Research on Progressive Supranuclear Palsy)

Deadline: 31-Jan-21 Amount: \$3,000

This award is open to **MD** and non-**MD** undergraduate students. Projects may be in basic, translational, clinical or epidemiological aspects of PSP, and must be supervised by a faculty mentor with expertise in the field. A maximum stipend of \$3,000 will be awarded.

## American Physiological Society (APS) Undergraduate Summer Research Fellowships

Deadline: 1-Feb-21

Amount: \$4,000 student stipend and up to \$1,300 in travel

Provides support for **first** – **third year non-MD undergraduate students** with little or no laboratory research experience to work for 10 weeks during the summer. Applicants must have an overall GPA of 3.0 or higher. Successful applicants will receive a \$4,000 student stipend, be eligible for up to \$1,300 in travel expenses, and receive a one-year complimentary APS membership.

American Society for Pharmacology and Experimental Therapeutics Summer Undergraduate Research Fellow

Deadline: 1-Feb-21 Amount: \$2,800

Open to **undergraduate students** interested in pharmacology research. Successful applicants will receive a stipend of \$2,800 for a minimum of 10 weeks participation in the program.

**ASH Physician-Scientist Career Development Award** 

Deadline: 1-Feb-21 Amount: \$42,000

Award for **first- to third-year medical students** to gain experience in hematology research. The award amount total is \$42,000 which includes a stipend, allowance for supplies, insurance/educational expenses and meeting attendance. The award is for a one-year period, generally July 1, 2021 through June 30, 2022.

Neurosurgery Research and Education Foundation Medical Student Summer Research Fellowship

Deadline: 1-Feb-21 Amount: \$2,500

Provides fellowships of \$2,500 to medical students. Students must have completed at least one year of medical school.

Society for Vascular Surgery (SVS) Student Research Fellowship

**Deadline: 1-Feb-21** Amount: \$3,000 USD

**MD** and non-MD undergraduate students are eligible to apply. Minimum commitment of 2 months and a maximum of 12 months. Each award consists of a \$3,000 USD student stipend and a two-year complimentary subscription to the *Journal of Vascular Surgery*.

Radiological Society of North America (RSNA) Medical Student Grant

**Deadline: 3-Feb-21** Amount: \$6,000

Open to **medical students** interested in radiologic sciences. Applicants are expected to undertake a full-time research project of at least 10 weeks long. A stipend of \$3,000 is to be matched by the sponsoring department (\$6,000 in total) and may not be used for non-personnel research expenses.

Dr. Khanh Dao Duc, Department of Mathematics, UBC

Unraveling translation dynamics and ribosome structural heterogeneity across scales and species

The translation of mRNA into protein is a fundamental biological process, regulated by the flow of ribosomes and many biophysical mechanisms that can locally modulate its dynamics. In the first part of this talk, I will present how we studied the determinants of translation dynamics and inferred position- and gene-specific translation rates, by combining deep sequencing experiments (Ribo-Seq) with biophysical modelling of the ribosome traffic. In particular, our study reveals the role played by a sub-compartment of the ribosome called the ribosome exit tunnel, which we confirmed by analyzing the ribosome atomic structure. We further considered evolutionary a spects of the exit tunnel, and studied the geometry, structure and sequence variation of the tunnel across species. In the second part, I will detail the extent of the tunnel variation across domains of life, which also explains certain differences between eukaryotes and prokaryotes in their translation mechanisms. With the recent surge of cryo-EM ribosome structures, I will finally mention our current effort to generalize this approach, and provide more integrative and computational tools to comprehensively analyze the structural heterogeneity of the ribosome, and investigate its biological implications.

How to get away with inequities in outbreaks & epidemics: a SARS-CoV-2 transmission modeling story

Some communities are disproportionately affected by epidemics – and the resulting inequities can sometimes be amplified depending on type of and access to interventions meant to halt epidemics. Dr. Sharmistha Mishra will talk about how to tailor public health interventions through data-drive transmission modeling studies centered around heterogeneity in risks, based on her collaborative work on the COVID-19 pandemic. She will discuss what the data and modeling studies suggest about heterogeneity in the conditions that lead to disproportionate risks of transmission and prevention gaps in Ontario, and the potential impact of tailored strategies. Dr. Sharmistha Mishra is an infectious disease epidemiologist and infectious disease physician, and a Tier 2 Canada Research Chair in Mathematical Modeling and Program Science based out of University of Toronto.

Dr. Daniel Pine is Chief, Emotion and Development Branch in the National Institute of Mental Health Intramural Research Program. Dr. Pine moved to this position in 2000, after 10 years of training, teaching, and research at Columbia University. Since graduating from medical school at the University of Chicago, Dr. Pine has been engaged continuously in research on pediatric mental disorders, as reflected in more than 600 peer-reviewed papers. Currently, his group examines the degree to which pediatric mood and anxiety disorders are associated with perturbed neural circuitry function. Dr. Pine served as the Chair of the Psychopharmacologic Drug Advisory Committee for the Food and Drug Administration, Chair of the Child and Adolescent Disorders Work Group for the DSM-5 Task Force, and President of the Society of Biological Psychiatry. He is a member of the National Academy of Medicine, a Distinguished Investigator indicating stature as among the 1-2% most impactful National Institute of Health intramural scientists, and has received many other awards.
